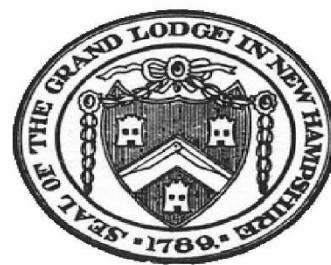
### DUES
